**MOVE UPS:** Email is preferred. Move-ups must be received by 6pm Monday July 31<sup>st</sup>.

**RUNNING ORDER:** Copies will be posted at the trial site. Exhibitor copies will not be available on site. If you would like a personal hard copy at the trial, you will need to print it from the website.

**LOCATION:** Canine Sports Zone 3036 Laura Lane, Middleton WI 53562 (GPS Coordinates: 43°06'25.5"N 89°30'53.4"W)  
There is ample space around the CSZ building to exercise your dog. **Remember to pick up after your dog!** Please don't exercise your dog on the grass of neighboring buildings. The area hotels are an extension of the trial site. Common courtesy and cleanliness will insure that they want us back next time!

**PARKING:** Please respect parking lot restriction signs on Friday. Neighboring businesses are open and need their parking. Street parking is allowed on both sides of the street. RV Parking is available but limited. Check with Canine Sports Zone \*before the trial\* regarding reserving RV parking.

**MEASURING:** Our judge, Kim Crenshaw, is a VMO and will be measuring dogs throughout the weekend when she is available (before and between classes.) Be sure to get your dog measured **before** your walk thru!

**CRATING:** Ample crating space is available. **Mats are required under crates.** Dogs with space issues must be covered and non-disruptive! CWVC and Canine Sports Zone will not be responsible for any lost or damaged items left at the show site. Dogs may **not** be left overnight. Building opens at 7am on Friday to exhibitors. **Thursday night set up is not available.** **This is a full trial. Please be considerate in your setup and conserve crating space whenever possible.**

**LUNCH:** Lunch & Snacks and soda/water will be provided for workers. Fast food restaurants are nearby for exhibitors.
