Gunshots will be required in all stakes. <u>Any handler choosing to Walk in the horseback stakes MUST indicate they are doing so</u> in the "notes to secretary". Failure to do so can invalidate your entry.

**NOTE:** Only blank guns with solidly filled barrels will be permitted. AKC approved tracking collars allowed, but not provided.
